Time to Deliver: Advocacy and Accountability Outside the Election Cycle at the National and Local Levels

September 11-13, 2024
Warsaw, Poland

The Institute of Public Affairs and the National Democratic Institute (NDI) invite you to the second international **Central Europe Civic Forum (CECF)**, an initiative of the **Central Europe Civic Engagement Project (CECEP)**.

CECEP supports citizen engagement in public affairs through advocacy on issues of citizen concern. Using evidence gathering, opinion research, and collective action, civic coalitions supported through the program engage policymakers on citizen priorities and thereby foster inclusive participation in public affairs. CECEP is implemented through a partnership between NDI, DemNet in Hungary, and the Institute of Public Affairs in Poland.

CECF is a venue for civil society leaders from Central and Eastern Europe (CEE) to share their experiences leading organizing efforts in their communities, demanding responsive and accountable governance at the national and local levels, and effecting change. In its second edition, we meet to share know-how on countering democratic decline and rule of law violation in CEE countries. Through a mix of small group discussion, expert presentations, and facilitated peer learning, the 2024 Forum will explore strategies for actively holding authorities accountable and influencing the political agenda outside the election cycle through systemic/policy-oriented measures at the local and national levels. The event also addresses roadblocks in civic organizing in CEE, including countering online violence, SLAPPs, and burnout.

From corrupt officials to systemic and grand corruption and state capture - examples of irregularities can be found all over Central Europe. However, in many cases, civil society organizations have been able to organize themselves, build broad coalitions of various actors, and counter these trends. In this panel, we will look at selected examples of such activities, with particular emphasis on those aimed at legislative changes and introducing specific mechanisms to combat corruption at different levels of government. At the same time, we will consider how these experiences can be applied in other countries - what to keep in mind and for which difficulties to prepare.

Central to conducting activism work is how to fund it. There have been ongoing discussions, including in the donor community, about the possibility of more flexible support. These considerations include funding both formal organizations and informal groups, as well as providing grants that are not tied to a specific project, allowing the recipient to decide on an ongoing basis what it needs to fund at the moment. Another topic is the possibility of funding activities aimed at supporting the well-being of employees, defending them from attacks, or investing in more long-term development of the organization. During this moderated discussion, representatives of several important grant-making entities in the CEE region will talk about the possibilities of funding that would consider above-mentioned aspects, but also the difficulties involved.
